Petitioner, pro se, respectfully requests the Court grant extension of time to to file his declaration and document in support of his U.S. citizenship, as ordered by this Court on December 6, 2011. This request is supported by the attached Memorandum of Points and Authorities, and the attached Declaration.

**MEMORANDUM OF POINTS AND AUTHORITIES**

Petitioner has been in contact with the Department of Vital Statistics for the State of Florida and has been informed by them that he must provide, along with his birth certificate application,


either a government issued photo identification or, lacking such, copies of three bills bearing his name.

Petitioner does not currently possess the identification or alternative documents required by the State of Florida in order to issue him a copy of his birth certificate. However, Petitioner is actively working at obtaining the required documents.

Moreover, Petitioner has changed his name in the past but had not requested the Department of Vital Statistics update their records to reflect that change. Petitioner was recently advised by the Department of Vital Statistics that he will also be required to submit a copy of a completed Form NC-130. Petitioner is currently in the process of obtaining the Form NC-130 but it may take up to 60 days.

For these reasons, Petitioner is unable, through no fault of his own, to provide the Court a copy of his birth certificate by January 6, 2012 and respectfully requests the Court extend the time to, at least, March 6, 2012.

**DECLARATION IN SUPPORT OF  
REQUEST FOR EXTENSION OF TIME  
TO SUBMIT CITIZENSHIP  
DOCUMENTS**

I, Richard Riess, hereby declare under penalty of perjury that I am the Petitioner in the captioned matter and that all statements made herein are true and correct to the best of my knowledge.

1. I was born on November 24, 1973 in the State of Florida.
2. I have been in contact, within the last 30 days, with the Department of Vital Statistics for the State of Florida.
3. The Department of Vital Statistics has informed me that I must provide, along with my birth certificate application, either a government issued photo identification or, if I do not have a government issued photo identification, then copies of three bills bearing my name

and current address.

4. I do not currently possess a valid, government issued photo identification, however, I am in the process of obtaining such. Upon my release from the custody of the Department of Homeland Security (DHS) in August 2011 my identification documents were not returned to me by DHS and have since been disposed of.
5. I do not currently possess any bills bearing my name and current address. Since my release from custody in August 2011 I have been residing at a friend's residence and all of the bills are in her name.
6. In 1996 I changed my name to Richard Riess and have, since, used that name exclusively.
7. I have been informed by the Department of Vital Statistics that in order to update my birth certificate I must provide a copy of the court order approving the change of name.
