

I, Desiree Capuano, do swear under penalty of perjury that the following is correct and true to the best of my knowledge. What follows is a detailed record of the events that have transpired since the last court hearing dated March 7th, 2014.

1. Immediately following the court hearing a very hurtful email was sent from the petitioner to myself designed to make me question the intent and true feelings of my son for me. This had the potential to cause a rift in the relationship between G [REDACTED] and myself although it did not.

(Exhibit A)

2. March 9th I received further communication from the petitioner describing how he does not manipulate G [REDACTED] and detailing how he reads our son all the court documentation to prove that he is not manipulating him. **(Exhibit B)**

3. It is my opinion that the communication initiated and continued by the petitioner to both myself and our son is intended to undermine the relationship between G [REDACTED] and myself. To cause G [REDACTED] to mistrust me, to make him question what my true intentions are, as well as to make him doubt what I say, all of which is unnecessary.

4. On March 11th a work colleague approached me and asked me very personal questions about my past. When I asked how she knew of this, she directed me to a LinkedIn account that had my name, my picture, and was connected to my profession account containing information such as;

- I was a stripper (exotic dancer)
- I smoked 'weed'

- I liked to 'drink beer and watch UFC'
 - That I was selfish and only cared about myself
5. By the time I was able to have this secondary account taken down, 33 professional contacts were connected to it and viewing it. **(Exhibit C)**
 6. On March 12th I discovered that the petitioner purchased a website by the name of 'www.desireecapitano.com' which he is now hosting and had posted all court documentation, personal and private information, all email communications, my arrest record from 2011 including mug shot, and all photographs he was able to secure through our son's social media accounts. **(Exhibit D)**
 7. On March 12th I sent an email to Mr. Lorenzo, who at the time was still the legal representative of Mr. Riess, explaining that I would no longer communicate with Mr. Riess and would only communicate through Mr. Lorenzo. I then ceased all communication with Mr. Riess. **(Exhibit E)**
 8. I confirmed with G [REDACTED] when he returned that he in fact knew about this website (although he did not know his father was accessing pictures of me through his social media accounts) and explained to him that I had to block him from my social media sites which would prevent anyone in Liz's family from seeing pictures of him that I posted, which was unfortunate.
 9. On March 23rd I received an email from Mr. Riess taunting me about the website, how my co-workers would see me "in my underwear" by visiting this website. He also indicated in the

communication that he would not stop posting every communication and every document he could. **(Exhibit F)**

10. On April 7th I received notification in the form of an email from Mr. Riess that Mr. Lozano would no longer be representing him in this court matter, forcing communication directly with petitioner once again.

11. On April 18th an email was sent from 'desi@desirecapuano.com' to every professional colleague and work associate that was connected to my LinkedIn account, written as me, with a picture of the mug shot, arrest record, and a link to the website **(Exhibit G)**

12. April 24th I received communication regarding the scheduled summer visit in which Mr. Riess informed me that G [REDACTED] was to fly on US Airways, flight number 1 on May 23rd at 1:55pm. That was the extent of the information provided **(Exhibit H)**

13. On April 27th another email was sent to my work associates, again from the 'desi@desirecapuano.com' email address, this time with information pertaining to Kristopher's arrest as well as an email conversation between the petitioner and myself in which Mr. Riess bolded a single sentence intended to make me look racist **(Exhibit I)**

14. As a result of the continued emails, I had to meet with the head of HR as well as the CIO of my company as it had the potential to damage my integrity not to mention my employment.

Fortunately I received nothing but support from every level of management up to the CIO level and my co-workers would not allow these defamatory actions to affect them or change their opinion of me. I was told that no matter what communication might be sent, my job was safe.

15. On April 28th I sent my first communication to Mr. Riess asking that he stop emailing the people I work with. I explained to him that these actions were harassing and that his aggressive behavior was making it impossible to co-parent or work together to create an open and healthy environment for our son. The petitioner denied any knowledge of the emails but indicated that there was valid reason for this behavior and he proceeded to detail why I was incorrect in my request to cease (**Exhibit J**).

16. One last email was sent to my colleagues with a link to a voice recording of the interview that occurred when I was arrested in 2011. I was informed of the email from a co-worker but most of them are simply deleting any messages from that address at this point.

17. May 11th I received a second communication regarding G [REDACTED]'s travel plans to Canada for the May 23rd visit. There was no additional information regarding the flight, just a demand to make sure G [REDACTED] had his passport. I responded to the petitioner that G [REDACTED] would have what he needed to travel but if there was no US Airways flight 1 on May 23rd at 1:55pm that G [REDACTED] would not be getting on any plane. Mr. Riess promptly replied with the confirmation number and detailed information regarding G [REDACTED]'s travel plans. (**Exhibit K**).

18. Mr. Riess purchased an airplane ticket from Arizona to California for May 23rd and made it appear that he would be with G [REDACTED] in California and that they would travel together to Canada at some point during the 2 week scheduled visit. This in fact did not happen at all. G [REDACTED] traveled to California to spend a few days with Liz and her family and then flew by himself to Canada for the remainder of the visitation. Although these plans were never discussed with me and I had no input into these decisions, I was ok with them.
19. 2 days prior to the scheduled visitation date, on May 21st, I received an email from the petitioner asking if I had objections to G [REDACTED] getting circumcised during the 2 week visit. I informed the petitioner that I did not agree and would not consent to such an operation. The petitioner stated that I had no say in that matter – to which I reminded him that I did. (**Exhibit L**)
20. On the evening of May 21st, Mr. Riess called and spoke with G [REDACTED] regarding an operation for circumcision to which G [REDACTED] informed Mr. Riess that he did not want to go through that operation at this time and he would make that decision for himself when the time came.
21. At 9:40pm on May 21st I received an email from Mr. Riess entitled 'Waiver of Rights' in which he states that he is waiving all of his rights to visitation and communication with G [REDACTED] and that it is solely up to me to determine whether there is communication or if G [REDACTED] in fact goes on the scheduled visitation. I informed the petitioner that his email did not change anything that was already scheduled and I had no intention of prohibiting or preventing communication between G [REDACTED] and his father (**Exhibit M**)

22. My understanding was that G [REDACTED] flew to Canada on May 27th. I never received confirmation that he made it. On May 28th I emailed the petitioner requesting G [REDACTED] to call me and confirm that he was in fact with his father. The response I received basically said that if I had not heard from my son it was probably because he did not want to talk to me. **(Exhibit N)**
23. I was able to speak with G [REDACTED] one time while he was with his father between the dates of May 27th and June 8th. G [REDACTED] was returned to me on the scheduled day of June 8th from Vancouver Canada.
24. On June 12th I received an email from the petitioner with the information for G [REDACTED]'s flight back to Canada scheduled for June 21st. In this communication Mr. Riess again reiterates that he has waived his rights and that it was solely up to me whether or not G [REDACTED] "attends that visit."
(Exhibit O)
25. On June 21st G [REDACTED] traveled to Canada as scheduled.
26. On June 24th I received an email communication from the petitioner accusing me of turning our son into a "lethargic, uninterested, unmotivated, slug..." among other things. Mr. Riess included G [REDACTED] in this email so that he could understand his father's disgust with his behavior. **(Exhibit P)**
27. If the petitioner and I were able to speak openly in a neutral environment I could explain to him that this behavior was not a result of me but more so a result of the fact that he is now a

teenager and the issues that Mr. Riess encountered with G [REDACTED] were the very same issues I have to work through with him too. Unfortunately that type of communication is just not possible.

28. Regardless of the petitioner's opinion on how I manage my household, G [REDACTED] was able to finish the school year with honor roll, having brought up his math grade and his state testing scores are very good (**Exhibit Q**).

29. The email sent on June 24th is the last communication I have received from either the petitioner or G [REDACTED]. I have not spoken to or heard from my son since he left Arizona on June 21st. I was told to call on the landline phone but it is not one of the 4 numbers I have. I have sent text messages and emails to G [REDACTED] and I assume that he is doing well.


30. I also have not received any information regarding G [REDACTED]'s return to me which is supposed to be for July 25th

31. To date, the 'desireecapitano.com' website is still up and active. I am working with the correct authorities to address the website as well as the emails that were sent as me.

32. I am not asking this court for anything, nor am I requesting or submitting a motion. The purpose of this declaration is to bring these events to the attention of the court and nothing more.

Desiree:

In the below communication you accused me, again, of manipulating G [REDACTED]. So, as I received those messages I read them to G [REDACTED] and made sure he understood exactly how I'm manipulating him. I said:

Son, if you're happy living with Desiree and you want to stay with her then I'll support that. I think it's a bad idea because of the way of life you'll be exposed to, and the lessons you won't be able to learn. But I'll support it nonetheless. And I'll continue to provide financial support and I'll do my best to try to teach you the life lessons that I think are import for you to learn to prepare you for life on your own.

So, that's me manipulating him? You're very sick in the head, Desiree. You need to get yourself some help. If you'd like I'm more than happy doing a conference call with all of us and I'll say those things to G [REDACTED], with you and anyone else you'd like to have present to witness it. That's what I've told G [REDACTED] since the very beginning.

And you heard it for yourself in court the other day: G [REDACTED] told the interviewer that he believes I want him to be with me because its what **HE** wants, and you want him to be with you because its what **YOU** want. He wants to be with me because I treat him with respect and dignity. Moreso, I **ACTUALLY** respect him. I've talked to him about that fairy tale of "love" and he knows that I don't believe in it. I've never said I love him and he's never said he loves me. So, you can tell him you love him until the sky falls - it won't matter because he's smart enough to know its just words.

You also said I'm spoiling him. Here's why you're wrong: when I started putting \$75 a week into his account I told him I'm not buying him any more video games or other things. I want to see if he can manage his allowance well enough to pay his financial obligations on time and still have enough to get himself the video games and things he wants. I would say that's the opposite of spoiling him. It's teaching him to be responsible with his money. He's responsible for making sure his phone bill gets paid on time. If he blows his money buying you and S [REDACTED] pizza and can't afford a game he'll have to wait until the next pay. So once again, it seems you're talking shit and being a fool.

Moreover, I think it's your approach to handling finances that's spoiling him. You don't provide him an allowance and make him manage his own money. You're that one that withholds the money from him and buys him things. That way he stays dependent on you and has to beg you for things. **THAT's** manipulation!

And, regarding the F he received in math: I'd like to ask why it is that you never bothered to inform me of it? Wouldn't a responsible parent have done so?

Anyway, I'm really getting very tired of always winning our little debates, but you just spew such stupid drivel and make such stupid arguments.

If you have anything intelligent to contribute then do so but please stop wasting our time with your silly allegations which are just projections of your own faults (like claiming I'm manipulating and spoiling G [REDACTED]).

P.S. I've spoken with G [REDACTED] about your claims that I took him and hid him from you all the time you were absent. I've shown him the pictures of Christmas 2001 when I brought him to your mother's place. I've pointed out to him that when he and I moved to Phoenix in 2006 I immediately contacted your mother to let her know and she visited

with him a few times. I've pointed out to him that he and I continued to live at the Anza address until 2003. And I explained that the reason I did not agree to give you his address when you came to CADC in 2009 was because I believed you would immediately take him from Liz's home and that would be very traumatic for him. I also pointed out to him that you raised those same allegations in court but they were immediately discarded by the court when I pointed out that in that 9 years you never once notified the court - which is all you would have had to do if your claim was actually true. I explained that all you had to do was inform the court and they would have issued a warrant for my arrest.

P.P.S. I've also shown him the documents you've filed in the court where you tried to have ALL communication between him and I prohibited, so stop trying to pretend that you wouldn't interfere with his and my contact. He doesn't argue with you about it because he's afraid of you and he doesn't think you'd tell him the truth anyway.

- Divorced the second husband (and father of the second child) in 2009
- Currently divorcing the first husband (and father of the first child)

- Was absent from the older son's life for 9 years, while traveling Europe and having a new life with the new family

You don't get it Richard. I was allowed to use marijuana the entire time I was in the TASC program. I never had to stop and I still completed the program successfully and all charges were dropped. 

[REDACTED] parked his car and then escorted us to his apartment. He opened the door. I asked him if we could step inside. He allowed us to enter.

Once inside, [REDACTED] spoke to Officer Ange about a counterfeit money case that she was working on. [REDACTED] claimed to have originally received the fake \$100 from a guy, [REDACTED] that he met at a pool hall. He said that he sold his pool cue to the guy for \$300. Once he learned that the money was fake, he found the guy again (the same night that he tried to pass the \$100 bill at Fascinations) again at the pool hall. He gave the guy back the remaining 2 bills and took his cue back. See Officer Ange supplement for further regarding the interview.

During the interview, I asked [REDACTED] if he had any more counterfeit money in the apartment. He said that he did not. After establishing that he shared a bedroom with his fiance Desiree Capuano ([REDACTED] pointed out his bedroom), I asked him if I could search his bedroom for counterfeit money. He said that I could but he did not know if Desiree would give permission. I again asked if I could search the bedroom. He stated, "absolutely".

I searched the bedroom that [REDACTED] claimed to share with Desiree. I discovered the following:

1. Large green bong - located in the master bath vanity



So, isn't what's happening now just the same thing you tried to threaten me with...except that I have no big secrets that I don't want surfacing.

Moreover, your aggressive behavior has made it impossible for us to communicate, co-parent, or work together to provide a safe, nurturing, and positive environment for G [REDACTED]; which is all that you and I should be concerned with.

That's grand! So, I assume things are not going well for you - because that's the only time you pretend to have any interest in what's best for G [REDACTED] and to speak as though you've ever made any attempt at being amicable. Shall we review your emails with a focus on chronology and point out how you've been persistently hostile and uncooperative...except:

- when the California and Arizona courts determined California would have jurisdiction - because you knew you were going to have to return G [REDACTED] to me;
- when we went for the first mediation - because you knew you had screwed up by taking G [REDACTED] to Arizona and the court was not happy with you;

You're the kind of person who would accuse a man of rape just to save yourself the embarrassment of admitting you had a one night stand with him; the kind of person that would lie about being forced by your father to have an abortion just to get your boyfriend to go along with your plan to have a child that you knew he wasn't ready for; the kind of person that would file a false report on your child's father to get him arrested so that you could get the child (even though the child didn't want to be with you); the kind of person that will turn a blind eye to their fiancée's meth use and shoplifting around your children. That's a bad person. Plain and simple! Those are not the kinds of things that decent people do. (Notice: everything I just mentioned is all stuff that you've done!)

I am willing to work with you in regards to G [REDACTED] but not in this hostile environment you have created. I see no hostility on my end. I've remained calm, civil and very methodical. Regardless, we're way past the point of trying to work together. I gave you the opportunity to do what's right and return G [REDACTED] to me last summer and you flatly refused. There are no more chances left for you.


